

## Debora L. Osgood

Debbie Osgood is a shareholder in Hogan Marren Babbo & Rose, Ltd.'s Education Practice. Ms. Osgood is a nationally recognized expert on the civil rights laws and regulations that govern educational institutions, having joined the firm after 25 years at the U.S. Department of Education (DOE), Office for Civil Rights (OCR).

At HMBR, Ms. Osgood has represented educational institutions, including public and private colleges and universities, accrediting entities and nonprofit organizations on a wide range of educational policy and legal issues. Her area of specialty is educational civil rights, including general discrimination issues, sexual harassment and sexual violence, gender equity in athletics, racial harassment and accommodations for students and employees with disabilities. Ms. Osgood seeks to help educational institutions position themselves to avoid legal claims of discrimination by students and employees and to effectively respond to these claims.

Prior to joining the firm, Ms. Osgood served as National Enforcement Director with the DOE's Office for Civil Rights from June 2012 to February 2016. In this position, Ms. Osgood was a member of OCR's senior leadership team and oversaw many of OCR's twelve regional enforcement offices. She advised senior OCR and other Department officials and regional enforcement staff on the investigation and resolution of cases under each of the civil rights statutes enforced by OCR, including Title IX of the Education Amendments of 1972, Title VI of the Civil Rights Act of 1964, Title II of the Americans with Disabilities Act of 1990, Section 504 of the Rehabilitation Act of 1973 and the Age Discrimination Act of 1975. She also provided national leadership and extensive training to OCR managers and staff on numerous substantive and procedural issues, including Title IX sexual violence, Title IX athletics, and OCR's "Case Processing Manual."

In addition, Ms. Osgood worked collaboratively with other offices in the DOE; as well as other federal agencies, including the U.S. Department of Justice (DOJ), and state agencies on civil rights issues. She previously held the Office Director and Chief Attorney positions in OCR's regional office in Chicago and worked at OCR under several administrations, including the Obama, Bush and Clinton administrations. While at the DOE, Ms. Osgood was selected as a member of the Federal Senior Executive Service, a cadre of top-ranking, career senior government executives with leadership and managerial expertise.

Prior to her government service, Ms. Osgood was an attorney with the Washington, D.C. law firm of Covington and Burling, specializing in federal communications and administrative law.
